The Institute

The Biomedical Research Institute of Lleida Fundació Dr. Pifarré (IRBLleida) was established with the aim of creating synergies between basic, clinical and epidemiological research, making biomedical research a key driver to improve current clinical practice. IRBLleida covers a chain of translational research, from basic research, aimed at understanding the physiological and pathological mechanisms of the human body, to research that studies the behavior of diseases in large population groups.

The Biomedical Research Institute of Lleida (IRBLleida) was founded in 2004 through a cooperation agreement between the University of Lleida (UdL) and the Catalan Healthcare system. IRBLleida integrates research groups of the faculties of Medicine and Nursing and Physiotherapy of the UdL. On the other hand, we incorporate research groups from:

- 1. The Catalan Health Institute (<u>ICS</u>) both at the hospital level (Arnau de Vilanova University Hospital <u>HUAV</u>) and the primary healthcare of <u>Lleida</u> and the <u>Alt Pirineu-Aran Health Region</u>,
- 2. The healthcare provider <u>Gestió de Serveis Sanitaris</u> (<u>GSS</u>; <u>Santa María University Hospital</u> <u>HUSM</u>, <u>Pallars Regional Hospital</u> and <u>Mental Health</u>, among others).

IRBLleida has been a CERCA institute since 2013, and as such is organized according to a model of good governance and operation that ensures efficiency, management flexibility, talent recruitment and promotion, strategic planning and executive capacity. It is also one of the 34 Spanish Health Research Institute (IIS) recognized by the Carlos III Health Institute and the Government of the Generalitat, as established by Law 16/2003, of 28 May, on the cohesion and quality of the national health system.

In December 2014, the Lleida Biomedical Research Institute's received the <u>'HR Excellence in Research'</u> logo from the European Commission. - Hold a university degree in bioinformatics or a related discipline.

Context and tasks to be developed:

The selected person will join the Institute for Research in Biomedicine of Lleida (IRBLleida) to fill a position of Bioinformatics Technician at the Scientific-Technical Service (SCT) Biostatistics.

The successful candidate will carry out the following tasks:

- Provide methodological advice on the design, data analysis and publication of studies of the research groups.
- Organisation and management of data according to the design of each study.
- Data analysis planned with the research team to meet their objectives. Interacting with researchers and resolving doubts in the interpretation of the results of the analyses.
- Participate in multidisciplinary teams to improve the processes of data collection, validation and integration in the research of the IRBLleida groups.

- Specific specialised training in bioinformatics and biomedical research.
- Proficiency in Python, Perl or R.

The Offer - Working Conditions

- Type of contract: Indefinite for scientific-technical activities, of article 23 bis of Law 14/2011, the object of which will be the performance of activities linked to lines of research or scientific-technical services, including the scientific-technical management of these lines, which are defined as a set of knowledge, concerns, products and projects, built in a systematic way around a thematic axis where activities carried out by one or more research groups converge and will require development following the appropriate methodological guidelines in the form of R&D&I projects.
- Expected start date: Immediately
- Duration of the contract: Staff costs are foreseen to run for 12 months.
 If there are modifications in the work programme and/or budget allocated to these tasks, the possibility of modifying the period will be assessed (the duration of the contract is linked to the specific funding of the agreement).
- This position includes part of the working day at the Centre for Genomic Regulation in Barcelona and part of the working day at the Institute for Biomedical Research in Lleida.
- The day at the Centre for Genomic Regulation will allow the selected person to enjoy an induction programme, work in the CRG Bioinformatics Unit, share knowledge, skills and technologies in areas of common interest.
- Approximate distribution of the working day, 3 days in the week Centre for Genomic Regulation, 2 days in the week IRBLleida.
- Working hours: 37.50 hours per week

Express selection process
