#### The Institute

The Biomedical Research Institute of Lleida Fundació Dr. Pifarré (IRBLleida) was established with the aim of creating synergies between basic, clinical and epidemiological research, making biomedical research a key driver to improve current clinical practice. IRBLleida covers a chain of translational research, from basic research, aimed at understanding the physiological and pathological mechanisms of the human body, to research that studies the behavior of diseases in large population groups.

The Biomedical Research Institute of Lleida (IRBLleida) was founded in 2004 through a cooperation agreement between the University of Lleida (UdL) and the Catalan Healthcare system. IRBLleida integrates research groups of the faculties of Medicine and Nursing and Physiotherapy of the UdL. On the other hand, we incorporate research groups from:

- The Catalan Health Institute (ICS) both at the hospital level (Arnau de Vilanova University Hospital -<u>HUAV</u>) and the primary healthcare of <u>Lleida</u> and the <u>Alt Pirineu-Aran Health Region</u>,
- 2. The healthcare provider <u>Gestió de Serveis Sanitaris</u> (<u>GSS</u>; <u>Santa María University</u> Hospital -HUSM, Pallars Regional Hospital and Mental Health, among others).

IRBLleida has been a CERCA institute since 2013, and as such is organized according to a model of good governance and operation that ensures efficiency, management flexibility, talent recruitment and promotion, strategic planning and executive capacity. ## Context and tasks to be developed:

The person will join the Translational Research in Respiratory Medicine group, within the research line "Precision medicine in obstructive sleep apnea", led by Dr. Ferran Barbé, from the Institut de Recerca Biomèdica de Lleida Lleida (IRBLleida). The work will be carried out in the context of project C100036 - Long-term cardiovascular outcomes in patients with Resistant Hypertension and Obstructive Sleep Apnea with or without treatment with continuous positive airway pressure. A prospective observational study (SARAH Study).



The selected person will join a multidisciplinary research group with high research activity, scientific production and a strong basic-clinical translational component.

Some of the tasks to be performed are the following:

- Collaborate in project data management (Data manager).







- Collaborate in the performance of basic and translational tasks in order to achieve the aims of the study.

### **Express selection process**

When an employee must be replaced urgently, for instance, to cover a sick leave, scientific reasons justifying the incorporation on a specific day, specification in a resolution, etc., an express selection process could be undertaken.
