The Institute

The Biomedical Research Institute of Lleida Fundació Dr. Pifarré (IRBLleida) was established with the aim of creating synergies between basic, clinical and epidemiological research, making biomedical research a key driver to improve current clinical practice. IRBLleida covers a chain of translational research, from basic research, aimed at understanding the physiological and pathological mechanisms of the human body, to research that studies the behavior of diseases in large population groups.

The Biomedical Research Institute of Lleida ([IRBLleida](#)) was founded in 2004 through a cooperation agreement between the University of Lleida (UdL) and the Catalan Healthcare system. IRBLleida integrates research groups of the faculties of Medicine and Nursing and Physiotherapy of the UdL. On the other hand, we incorporate research groups from:

1. The Catalan Health Institute ([ICS](#)) both at the hospital level (Arnau de Vilanova University Hospital -[HUAV](#)) and the primary healthcare of [Lleida](#) and the [Alt Pirineu-Aran Health Region](#),
2. The healthcare provider [Gestió de Serveis Sanitaris \(GSS\)](#); [Santa María University Hospital -HUSM](#), [Pallars Regional Hospital](#) and [Mental Health](#), among others).

IRBLleida has been a CERCA institute since 2013, and as such is organized according to a model of good governance and operation that ensures efficiency, management flexibility, talent recruitment and promotion, strategic planning and executive capacity. Context and tasks to be developed:

The selected person will join the IRBLleida to fill a position of senior research technician for the SCT-Citometry and Microscopy. The Service supports the IRBLleida research staff by making available its equipment and knowledge of experimental design. The Service has a flow cytometer analyzer, a magnetic cell separator and a cell separator inside a level 2 biosafety cabinet. It will also develop optical microscopy tasks.

The tasks to be performed will be the following:

- Management and maintenance of the Service's equipment
- Preparation of samples for flow cytometry experiments: samples from patients, or from housed animals or cell cultures.
- Procurement of samples to the different teams of the service.
- Support to users in optical microscopy
- Support in laboratory management (orders, invoicing, protocols).
- Training new users in the use of the service's equipment.
- Tasks related to biosafety and good laboratory practices: creation of standard operating procedures in accordance with ISO9001 standards and technical instructions for the different equipment and protocols used in the laboratory.

Express selection process
