



#### 1. Call Opening

#### 1.1. Introduction

The "Institut de Recerca Biomèdica de Lleida Fundació - Dr. Pifarré (IRBLleida)" opens the first call Four-year PhD Fellowships. This call is financed with funds from the Diputació de Lleida and IRBLleida. The communication of this call will be made through the website, social networks and corporate email list by subscription of the IRBLleida, as well as other web portals for this purpose. The framework regulations for this call lies in:

- Royal Decree 103/2019, of March 1, 2009, which approves the Statute of the Predoctoral Research Staff in Training. Predoctoral Research Staff in Training.
- Article 21 and additional provisions one and eighteenth of Law 14/2011, of June 1, 2011, on Science and Technology. 14/2011, of June 1, 2011, on Science, Technology and Innovation.
- Royal Decree 2720/1998, of December 18, 1998, which Article 15 of the Workers' Statute is developed in relation to fixed-term contracts. fixed-term contracts.

## 1.2. Summary

The grants will consist of the formalization of an employment contract, under the form of a pre-doctoral contract. The purpose of the contract will be to carry out research tasks, within the scope of a specific and innovative project, on a full-time, for a fixed term, which may not exceed four years, except in the cases included in point 2.2.

#### 2. Call Description

#### 2.1. Scope

The purpose of this call is to promote the retention and attraction of research talent in the predoctoral stage (R1), through the granting, in a regime of publicity, objectivity and competitive concurrence, of 3 grants aimed at the completion of the doctoral thesis within the research groups of the IRBLleida.

The applications submitted, within the framework of this call, must be linked to the completion of the candidate's doctoral thesis in the field of biomedicine within one of the IRBLleida research groups, under the supervision of a single researcher (for the purposes of this application) who meets the requirements described in section 3.1.





### 2.2. Funding & Payment

An employment contract will be formalized with the beneficiaries of the grant, which will have the following characteristics:

- The contract will be formalized between the predoctoral research personnel in training in their capacity as workers and IRBLleida in its capacity as employer.
- The contract must be accompanied by a letter of admission to the doctoral program by the unit responsible for the program or by the doctoral school, as well as proof of payment of the enrolment fee. This documentation must be updated annually.
- Situations of temporary disability, risk during pregnancy or breastfeeding, maternity, adoption, custody for adoption purposes or fostering, and paternity will suspend the duration of the contract. Likewise, situations foreseen in article 45.1.n) of the revised text of the Workers' Statute, as a measure to protect women who are victims of gender-based violence, will also suspend the duration of the contract. In case the contract is interrupted due to any of the mentioned situations, it will be extended for a period equal to the interruption.
- The gross annual remuneration that the contracted person will receive will be determined by the current and public salary tables of IRBLleida for the corresponding category.
- The grant beneficiary will be directly awarded an International Mobility Grant for Predoctoral Modality from IRBLIeida's IREP program, which they can enjoy during the last two years of the predoctoral contract. The beneficiary must adhere to the regulations of the International Mobility Grant bases for Predoctoral Modality of IRBLIeida, without the need to go through the selection process.

#### 2.3. Duration & Important Dates

The contract will have a maximum duration of 48 months, except in the cases included in point 2.2, with full-time dedication (37.5 hours per week).

The duration of the contract is conditioned to the continuity of the beneficiary in the doctoral program. In any case, the contract will be resolved when the candidate obtains the doctorate degree or 48 months after the start date of the contract.

# 3. Candidates profile

# 3.1. Eligibility

The requirements for participants are as follows:

- Degree of Licentiate, Engineer, University Graduate with at least 300 ECTS (European Credit Transfer System) credits, or a University Master's degree, or equivalent, at the time of acceptance of the grant.
- Not hold a doctoral degree.
- Be enrolled or have a letter of admission, at the time of acceptance of the grant, in one of the doctoral programs in the field of biomedicine that are eligible within this grant.
- Not have previously any predoctoral contract before the grant application.

The requirements for the Thesis Director supervising the applicant are as follows:

- Must hold a Doctoral degree.
- Have an affiliation with IRBLleida, either through a contract with the Institute or as an affiliate through a specific agreement with their contracting center (UdL, ICS, or GSS). The affiliation with IRBLleida must have a minimum duration of 6 months prior to the application deadline and must remain in force throughout the entire Thesis project.
- Belong to a research group at IRBLIeida at the time of the grant application.
- Be the Principal Investigator (PI) of an active extramural competitive project (regional, national, or international) at the time of the application deadline and the start of the predoctoral contract.

#### 3.2. Incompatibility

The contracts will be incompatible with any other employment contract by the predoctoral researcher.

No person acting as a thesis director may appear in more than one grant application in this call. The submission of more than one application by the same person will result in the exclusion of all the affected applications.





# 4. Application & Award Decision

## 4.1. Proposal Submission

All the applications for this call must be submitted through the link provided in the IRBLleida website in the intramural research calls section.

To formalize their application, the candidates will have to submit:

- A standardized application form, including the scientific-technical proposal, with the corresponding responsible declaration signed by the candidate and thesis director.
- Academic certificate of the Bachelor's and Master's degrees, accrediting the completion of the required training to access the doctoral program, having completed a minimum of 300 ECTS credits at an official university at the time of submission of the application. The certificate must contain the subjects taken during the corresponding degree, as well as the grades obtained. If the candidate has not completed the Master's studies by the application deadline, they must provide documentary proof of completion and the obtaining of 300 ECTS at the time of acceptance of the grant, if their application is prioritized. In this case, the average grade of the bachelor's degree will be counted 100% during the evaluation process.
- Applicants who have completed their bachelor's, degree, diploma, or master's studies partially or entirely at institutions outside the Spanish university system must accompany their academic records with calculated equivalency declarations, in accordance with the provisions of the Ministry of Universities: <u>Grade Equivalency Calculation</u>.
- Abbreviated Curriculum (CV) of the candidate.
- Document accrediting pre-admission or enrolment in a Doctoral program in the field of biomedicine, within the Health Doctoral program. If the candidate does not have this document by the application deadline, they must present it at the time of acceptance of the grant if their application is prioritized.
- Abbreviated Curriculum Vitae (CVA) of the Thesis Director in FECYT format.
- Acceptance letter from the Thesis Director.
- Supporting documentation for the merits of the candidate included in the CV for evaluation (except participation in projects and publications).
- If the Thesis Director falls under any of the circumstances described in point 2.2, it will be necessary to attach supporting documentation to extend the evaluation period of their scientific merits by a period equal to the documented leave time.





#### 4.2. Evaluation Criteria

The evaluation of the received applications will be divided into 3 sections:

# - Evaluation of the CV of the candidate (50%)

The Internal Scientific Evaluation Committee (CIAC) of IRBLIeida will evaluate, in the first phase, the CV of the candidates based on various criteria contained in the following table:

### - Evaluation of the Thesis Director (40%)

The Internal Scientific Assessment Committee (CIAC) of the IRBLleida will evaluate, in a second phase, the publications and scientific production of the thesis director in the last 5 years, where the main authors are considered the first and last signatories of the manuscript, and the authors of correspondence. The ability of the director to obtain funding through competitive public projects and the alignment of the active projects to the present proposal will also be evaluated. An additional 20 points will be awarded if the thesis director is the PI of a "Generation of Knowledge 2022" project (AEI 2022) or of an R&D&I project in health (AES 2022), provided that at the time of closing the call period, the director has not been granted (provisionally or definitively) a FI-AGAUR Joan Oro 2023 or 2024 grant, a "Personal Predoctoral en Formación UdL 2024" grant, a PFIS 2023 grant or a FPI 2022 grant, associated with said project. This 20-point bonus is linked to the project and can only be granted to one of the co-IPs, if there is more than one. Finally, the training capacity of the thesis supervisor will be assessed, as well as his/her transfer activity.

For the calculation of the 5-year period that will be considered for the evaluation of the thesis supervisor's merits, the assumptions included in point 2.2 will be considered.

Applications will be evaluated by the IRBLIeida Internal Scientific Evaluation Commission (CIAC) according to the following criteria:

#### 5. Beneficiaries' obligations

After the awarding of the grant, the following rights and obligations arise, which affect both candidate and thesis director:

#### 5.1. Project Follow-up

The doctoral student will provide documentary evidence through the e-mail <u>projects@irblleida.cat</u> of any training received or stay carried out during the development of the thesis.

Thesis directors must report any absences, temporary or permanent leave of the doctoral candidate, or any other events related to the candidate. Additionally, they must notify the completion of the doctoral thesis to the IRBLleida Project Department (projects@irblleida.cat).

- Annual follow-up reports: the beneficiary of the grant must submit an annual report (every June), following the standardized model for this purpose, summarizing the main scientific milestones achieved during the period to which the report refers (maximum length of 1 page). In addition, a list of the activities carried out within the framework of the grant (attendance to congresses, presentations, training, etc.) must be submitted. In the case of beneficiaries enrolled in a doctoral program at the UdL, they may submit the annual evaluation report submitted to the doctoral schools instead of the monitoring report detailed above. Failure to submit the annual monitoring reports or the negative result of the evaluation reports of the doctoral program may lead to the termination of the contract.
- The beneficiary doctoral student is obliged to present two seminars of the scientific program "Friday Seminars". The first one before the end of the second year of the contract and the second one before the last semester of the fourth year. In addition, he/she must participate in other mentoring activities approved by IRBLleida.

#### 5.2. Project Outputs

- A change of thesis supervisor may only be requested in extraordinary situations that affect the proper development of the beneficiary's doctoral thesis. Such





situations include the loss of affiliation/contract with IRBLleida by the supervisor or conflicts between the candidate and the supervisor.

- The IRBLleida management has the authority to assess the relevance of the request for a change of supervisor. If it is deemed that the request is in the best interest of the candidate, it will be presented to the CCI (Interdisciplinary Scientific Committee), and if recommended by the CCI, it may be approved by the management.

#### 5.3. Final Reporting

Any material made public within the framework of the project linked to the grant from this call, as well as any dissemination actions involving the grant beneficiary, must include a mention of the internal funding sources from the Diputació de Lleida ("This work has received funding from the Diputació de Lleida – La força dels Municipis") and from IRBLleida ("This work has received funding from the IRBLleida Intramural Research Grants Program"). The thesis director, responsible for each predoctoral researcher, must inform the IRBLleida Innovation Office (<a href="mailto:innovacio@irblleida.cat">innovacio@irblleida.cat</a>) of the material to be disseminated, in order to assess its potential for protection.

#### 5.4. Final Justification

- Final report: The PhD student must submit a final report (in the last month of the year in which the grant ends), following the standardized format for this purpose, which should include a summary of the achievement of the initial project objectives through the scientific development executed (maximum length of 3 pages). Additionally, a list of conference attendances/presentations and scientific publications made within the framework of the grant must be provided.
- Submit a PDF copy of the final doctoral thesis document once defended, as well as inform about the grade received.

#### 6. Other Clauses

Participation in this call for proposals implies knowledge and acceptance of all its terms and conditions, including:

#### 6.1. Proposal Documentation Confidentiality

The documentation associated with the proposals will be treated as confidential information, being obliged to maintain the confidentiality of the information all persons involved in the evaluation and assessment of the proposals, and may be used for informative and dissemination purposes, subject to prior consent of the applicants.





# 6.2. Terms and Conditions, Industrial and Intellectual Property

The intellectual or industrial property and exploitation rights that may derive from the implementation of the granted idea will belong to IRBLleida, recognizing as authors or inventors the people who have conceived and implemented these ideas and applying the intellectual and industrial property regulations of IRBLleida.

### 6.3. Personal Data Collection Purpose and Processing Information
