

Miguel Servet 2025 Prioritization process



1. Call Opening

1.1. Introduction

The Biomedical Research Institute of Lleida Dr. Pifarré Foundation (IRBLleida) has established a policy of promoting to Tenure researchers who have terminated their Tenure Track positions under the Miguel Servet program and have positive evaluation by the ISCIII. This stabilization is the end point of a tenure track program with which our Institute supports these young researchers throughout the five years of their Miguel Servet contract so that they can develop professionally and become researchers with the ability to lead their own lines of research and/or research groups.

1.2. Summary

The aim of this selection process of candidates is to ensure the entry of new researchers with quality criteria, but also strategic, to give added value to the research carried out in our Institute.

2. Call Description

2.1. Scope

Currently, at IRBLleida we have one stabilized "tenure" researcher and six "tenure track" who will apply for stabilization in the coming years. In this context, the IRBLleida management believes that the incorporation of new "tenure track" researchers should be limited to avoid creating a financially compromising situation for our institution in the medium to long term.

2.2. Funding & Payment

For 2025, a position is open for candidates who successfully pass the selection process detailed below to apply for a Miguel Servet position in the AES 2025 call.

2.3. Duration & Important Dates

All those who are considering applying for a Miguel Servet contract in the AES 2025 call must submit an expression of interest to the email address projects@irblleida.cat.

- Expression of interest submission: Until February 17th, 2025, at 3:00 p.m.
- Submission of documents for prioritization: Until February 21st, 2025, at 3:00 p.m.

• Internal submission and signature in the ISCIII application: Until March 5th, 2025.

3. Candidates profile

3.1. Selection Criteria

The prioritization of candidates will be carried out in two phases:

• **1st phase** – The IRBLleida Internal Scientific Evaluation Committee (CIAC) will use the evaluation criteria of the Miguel Servet 2025 call in order to prioritize the candidates participating in the process.

To move on to the second phase, the candidate must score a minimum of **32** points out of the 70 maximum points they can obtain, which represents 80% of the average cutoff score of candidates who were awarded a Miguel Servet position from the 2021 (39.50), 2022 (41.00), 2023 (36.50), and 2024 (41.05) calls.

• 2nd phase - Candidates who pass the first phase will be required to give a brief presentation of their CV and explain the potential benefits of their incorporation into our institute in terms of synergies with other research groups, the introduction of new techniques and protocols, etc. The presentation will be telematic and will last a maximum of 15 minutes plus 10 minutes for questions. The evaluation panel will be made up of the Director and Deputy Director of IRBLleida, a member of the Internal Scientific Committee (CCI) who has no conflict of interest with any candidates, and two members of the External Scientific Advisory Board (ESAB). If the Director has a conflict of interest with any of the candidates, their position will be delegated to a CCI member with no conflicts of interest. To pass the second phase and be considered a prioritized candidate, the minimum required score is 15 points out of a maximum of 30 points.

4. Application & Award Decision

4.1. Proposal Submission

The required documentation must be submitted through the link provided for this purpose in the intramural calls section of the IRBLleida website (https://www.irblleida.org/es/convocatorias-intramurales/).

To formalize their application, candidates must submit:

- Candidate's CV following the ISCIII template (maximum 8 pages).
- Selection of the 10 best publications from the last 5 years (IRBLleida template, Annex I).
- Miguel Servet AES project proposal document.

4.2. Evaluation Criteria

4.3. Award Decision

Once the candidate evaluation process is completed, the CIAC will send the prioritization of applications and the evaluation reports for each candidate to the Director of IRBLleida (or their designated representative). This prioritization will indicate the selected candidates and those placed on the reserve list. The Director of IRBLleida (or their designated representative) will issue a provisional award resolution, naming the selected candidate for this call and providing a prioritized reserve list of candidates.

5. Other Clauses

Participation in this call for proposals implies knowledge and acceptance of all its terms and conditions, including:

5.1. Proposal Documentation Confidentiality

The documentation associated with the proposals will be treated as confidential information, being obliged to maintain the confidentiality of the information all persons involved in the evaluation and assessment of the proposals, and may be used for informative and dissemination purposes, subject to prior consent of the applicants.
